RALLY PHILOSOPHIES

Highway Robbery, on Saturday, October 21, 2017, is a course rally that will test your ability to stay on course and on time. This year's will run partly in the Santa Monica mountains (new territory for Highway Robbery), and partly in the Santa Clarita/Antelope Valley area. There will be no Aristotle or absence of the sign traps, and there will be a fixed main road. In fact, you can run Highway Robbery using the SMSCC General Instructions with a short addenda instead of the RRRs if you want to. These are the same generals that we used last year. The rallymaster expects most contestants to do most legs correctly.

Future Shock, on Sunday, October 22, 2017, is a trap-gimmick rally on which you do not have to stay on time, so you have time to re-read the rules, and to go back to recheck a sign or an intersection, and to actually THINK about what you're doing.

START / HEADQUARTERS

Rally headquarters is the Valley Inn & Conference Center, 10621 Sepulveda Blvd, Mission Hills, CA 91345, (818) 810-6676. Room rates are \$90 per night for a room with two double beds, mention Santa Monica Sports Car Club when you call. Friday night registration and the start locations of both rallies on Saturday and Sunday mornings will be here.

DIRECTIONS

From Los Angeles International Airport (LAX) (about 25 miles): Exit airport East on Century Blvd. Right/North onto Interstate 405. Exit at Devonshire Street (just before the 118 freeway). Right onto Devonshire (at end of offramp). Left at traffic light onto Sepulveda. The Valley Inn is on your left before you get to the next traffic light.

From Bob Hope Airport (BUR) (about 10 miles): Exit airport East (on Thornton Ave.). Left/North onto Hollywood Way. Left onto Interstate 5 North. Follow signs onto 118 West. Exit at Sepulveda Blvd. Left at traffic light onto Sepulveda (at end of offramp). The Valley Inn is on your right soon after crossing Chatsworth (a traffic light).
